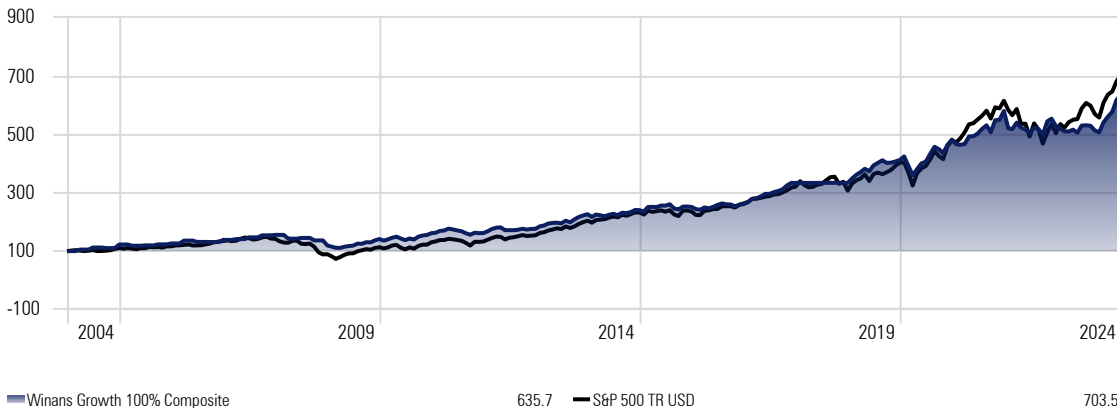

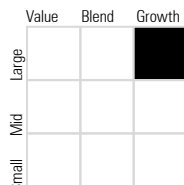

Morningstar Equity Style Box™

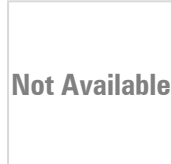
